Presidents Report

Thanks to the events of the past few weeks, I find it impossible to ignore and must address. It just amazes me how the "brain trust" in this district just never seems to stop coming after the craft that is doing the hard work, and forces me to address their treatment of our craft. I am referring to last month's pre-walks their "misfit" inspection team threw at a couple of our offices where they believe they can take out some routes! Good luck with that! Remember the last time management tried to run their own inspections without the help of the NALC? It cost them millions of dollars nationwide as well as locally. They brought their total disrespect of our craft by trying to intimidate and harass the carriers from the offices they did their pre-walks with. It started by their trying to say a pre-walk doesn't adhere to the same rules as a regular inspection! Really? Where in the M-39 does it state that nonsense? They came in with guns blazing by telling carriers they had to double up all relays, even with ADVO's, because that is the way it is going to be! Never mind the routes are not set up that way, they said to do it anyway! They then instructed carriers to work out of the front of their vehicles instead of out of the back! Now this is coming from a group of people who never carried a piece of mail in their lives! Oh yea, they know best on how to deliver a route. You know, they manage rural routes in the sticks, so they are definitely an authority on city delivery. They then tried to say it was a safety issue, but when I inquired about the carriers who use vans and work out of the back they seemed dumbfounded! What a bunch of disgraceful people who have no clue on delivering mail. I can go on and on to describe this pathetic showing of management flunkies but won't, because it is the holiday season. For the record, not all of these people should be included in my assessment, but we all know who the "biggest losers" in this group are. Another issue I must mention, since I was never given the courtesy of an answer by the district manager last year, even though he agreed to look into it. Had they looked at the cost factor of this DUO, I believe they would have never gone through with it at this time. You have routes that never worked overtime and were able to absorb some of the auxiliary route on a daily basis. Now you have carriers driving 45 minutes to give help to these routes when they have to break up the route. You have carriers now making 80 grand instead of 60 grand doing their same route! Not a brilliant strategy if you ask me! This is only the beginning! Hope to see you at the Christmas meeting, but if not, have a safe and happy holiday!

Grievance Log Step B Decision

Blackwood- Management was in violation of Article 7.1.C.4 when they failed to utilize two PTF carriers at the straight-time rate over the course of the service week in question prior to utilizing CCA's. As remedy the following two PTF carriers will be compensated **8 hours** each for the lost straight-time work opportunities.

Blackwood-Management violated Appendix B and the joint CCA questions and answers when they involuntarily reassigned the grievant from the Blackwood Post Office to the Pennsville Post Office. As a remedy, the grievant shall be immediately returned to Blackwood as a CCA and made "whole" at the applicable mileage rate for the additional expense he incurred due to the increase in his daily commute that resulted from this violation.

Deptford- Management violated Article 41 of the national agreement when they removed a CCA from her hold down assignment. As a remedy, the grievant shall be "made whole" by compensating her for the difference in the number of hours actually worked and the number of hours she would have worked had she not been improperly bumped from her assignment. A payment of **8 hours** at the overtime rate will be paid to grievant.

Deptford- Management violated Article 41 of the national agreement when they removed a CCA from his hold down assignment. As a remedy, the grievant shall be "made whole" by compensating him for the difference in the number of hours actually worked and the number of hours he would have worked had he not been improperly bumped from his assignment. A payment of **8 hours** at the overtime rate will be paid to grievant.

Deptford- Management violated Article 8.5.G of the national agreement when the required non-ODL and work assignment carriers to work approximately 17 hours of overtime when ODL carriers were available. As a remedy, **1 carrier to receive 10 hours, 2 carriers to receive 1 hour, and 8 carriers to receive .50 hours,** at the overtime rate.
