### **Presidents Report**

I would like to open this month's report with a shout out to all those CCA's who attended last month's rescheduled meeting. It was the largest showing since the CCA category was established, and I hope this trend continues. We are looking at possibly having a CCA only meeting to address all of the questions and concerns it appears many of our new brothers and sisters are having. If you would like the branch officers to arrange this special meeting, please drop me a line or let your steward know if you would be interested in such a meeting. If we get enough interested CCA's to respond, I would be more than happy to accommodate you. Based on some of the questions we received last meeting, it appears many of you aren't too aware of your rights and many of your responsibilities that are associated with your job. I hope we answered the questions and concerns from the ones who attended and look forward too many more members to come out and ask your questions and make your job less stressful by learning your rights. My one suggestion to those in attendance was to download the NALC app on your phone and go to the section on workplace resources and click on the CCA resource guide. It has everything you will need to know in learning your rights and responsibilities as you wait to get converted to a career position. There was one item I shared with those in attendance, that I want to share with the rest of the CCA's, which deals with the money you are losing by skipping your lunches and/or breaks. This is a number management doesn't want you to know, because they love it that you are donating money back to them. If you skip your lunch you are losing \$8.59 per day, \$52.14per week, \$208.56 per month and \$2502.72 per year. If you skip your two ten-minute breaks you lose \$5.60 per day, \$33.60 a week, \$134.40 per month and \$1612.80 per year. That adds up to over <u>\$4000.00 a year in lost monies</u>, which management won't tell you. So, I ask you to think about the money you lose by skipping these two guaranteed parts of your job. Also, when you work off the clock you lose additional monies as well. Think about the special meeting I am suggesting and let me or another officer or steward know if you would like to schedule one.

The next item this month, which I am really getting annoyed with talking about, is the issue with time-card theft, and the reaction from the guilty parties. Last month we identified Williamstown of theft and manipulations, and this month we have found Stratford and the Camden annex of stealing from our members. What really is starting to annoy me is how the managers in these installations want to shift blame to the union for making an issue of these findings. Are you kidding me or what? We didn't steal money from the hard-working carriers, you did! Stop trying to hide behind the fact you are thieves and are upset because we have caught you dead to rights. The district manager has gone on record saying he won't tolerate this behavior from any employee guilty of these antics. So, I suggest to any manager who is stealing, either fess up and say you are being told to do this or face the possibility you may lose your job for theft. This branch will not stop pushing to have those who steal removed or given the penalty that any craft member would receive for a like offense. We will continue to investigate all managers we believe may me stealing time from our members until they just stop! I ask all carriers to start looking at your paychecks for missing time. It seems to happen when carriers may be working after 18:00 or may need an 8-hour day to avoid paying penalty time. We also noticed managers are not

paying carriers who may have been expected back at a certain time and didn't return at the time they were expected. We also noticed managers giving carriers extended lunches to make it look like they are not working for certain times. It is now obvious this practice has been going on for a long time with no one looking. Well, I can tell you we are now looking and will continue to look until this practice stops. Please don't be intimidated not to clock in or out by your manager. If they ask you or order you to do this please let your steward or notify me immediately.

Another item to mention is the unilateral program the postal service is trying to implement called the <u>Safety Ambassador</u> <u>Program</u>. I won't go into detail about this program, but all I can say it replaces the safety captain program and is not a program the NALC endorses. I am asking all carriers not to be persuaded to join this initiative, as it is not for the benefit of the membership.

Lastly, we are in the midst of finishing up route inspection issues in our Bridgeton office as the 60-day review has been completed and we are waiting on the team to come back in a walk the over-burdened routes. Once the routes are walked and the times are verified, we expect see a route put back in there at least, based on the data I have reviewed. As for the other offices, Bellmawr is almost done their 60 days and Riverton is looking to do a local adjustment without using COR. Hopefully, we can mutually work with the team to get these accomplished without filing grievances. Hope to see everyone at this month's meeting. - Gary DiGiacomo – President

### **Attendance Prize Now at \$100**


