Presidents Report

As we head into the spring, our negotiations for a new contract will start to get serious in the month of May. Last month, many of your officers and stewards attended our Region 12 seminar in Atlantic City, where new National President, Brian Renfroe, addressed the attendees on what the NALC's plan is going forward with contract negotiations and many other issues that are of concern for the members. I discussed many of those items at last month's meeting but will briefly discuss some here for those unable to attend. I would like to give a shout out to a lot of those new members who came out last month, along with those retirees and active members who made the meeting. It was nice to see our numbers at meetings rising. I hope this continues. Speaking of our seminar in AC, President Renfroe laid out a detailed report on what our union will be looking to accomplish this round, which I will highlight here. He did ask that everything we discuss in our meetings be kept in house and not on social media, since this could hamper our negotiations. He stated if things leak out, he would have to keep our positions quiet so as not to hurt our bargaining position. I will not go into our strategy in this or future newsletters, but will keep everyone updated at our meetings. One major issue he did address, which is quite revealing, dealt with our participation in the Letter Carrier Political Fund (LCPF.) He stated out of our 280 thousand members, only 30 thousand members donate to this fund. That means over 250 thousand don't give to this PAC. Our branch is doing quite well, but we need more of our members to start helping out, since this is extremely important for us to get our issues heard in Congress. Let's face it, in DC, money talks and BS walks. He said he understands many members don't want to give, but maybe they really don't understand why we need this. We have a lot of legislation that needs to get to the floors of both houses, and by having money to give to those who support us, we can get this done. It doesn't matter what your affiliation is, our money goes to both parties who support our plight. For instance, the Social Security Fairness Act (S-597) has finally made it to the floor of the Senate for the first time. We now have 36 bi-partisan co-sponsors, and with everyone's help, we could possibly get the Offset and Windfall elimination bills repealed for all those affected. This is just one bill your money can go to. Please think about giving to this fund and talk to our LCPF officer Ozzie Lecky for all the latest info. Next, he mentioned we are looking to establish an all-career workforce along with higher starting wages, since the non-career force is no longer viable. He stated something must be done to address the high cost of uniforms and the safety of our carriers who are dealing with issues on the street in some areas of the country. He stated the route evaluation program will probably continue as well. He is trying to get the 520-hour annual leave carryover to become permanent. He stated the new S&DC buildings are coming, but not as fast as you may be hearing from your managers. Don't listen to them, he will notify us when dates are imminent. He recommended that everyone register on ECOMP, which we have been saying since it started. If you aren't aware of how to do this, please talk to your steward or any officer for assistance. Those are some of the main issues he spoke of. Next, I have been getting calls from members who are telling me we have carriers working off the clock again. I am not sure why anyone would want to work for free, and why managers would

allow this to occur, but if it is happening, which I know it is, it must stop. We are going to begin filing grievances for those carriers working off the clock, so managers **BEWARE!** You are not helping your office by working off the clock. All you are doing is showing less time for routes, and that will get routes taken out of your office or routes added to. Please don't be intimidated to do this, or tell me you have to get done to go to another job, etc. Take the time you need each day and stop thinking you are doing anyone any favors by working off the clock. Lastly, we have three by-laws in this month's newsletter we will be discussing and voting on at this month's meeting, so please read them and come to the meeting to discuss them. Thanks, and I hope to see everyone at this month's meeting.

The elected officers of the Branch, in ranking order, shall be the President, **Executive Vice President**, Vice President, Recording Secretary, Treasurer, **Assistant Treasurer**, Financial Secretary, Assistant Recording Secretary, Trustees' Chairperson, four (4) Trustees, Health Benefits-MBA-NSBA Representative, Sgt. At Arms, Housing Chairperson and a Letter Carrier Political Fund (LCPF) Officer.

Article 4: Section 4: Currently Reads: The Branch Executive Board shall consist of Branch President, Vice President, Recording Secretary, Treasurer, Financial Secretary, Assistant Recording Secretary, The Chairman of Trustees, The Trustees, Health Benefits Officer, Housing Chairman, Sergeant at Arms and Letter Carrier Political Fund Officer.

Proposed Change:

The Branch Executive Board shall consist of Branch President, **Executive Vice President**, Vice President, Recording Secretary, Treasurer, **Assistant Treasurer**, Financial Secretary, Assistant Recording Secretary, The Chairman of Trustees, The Trustees, Health Benefits Officer, Housing Chairman, Sergeant at Arms and Letter Carrier Political Fund Officer.

Article 5: Section 1:

Currently Reads:

Nominations for the election of Branch Officers, Shop Stewards, and Convention Delegates shall be called for at the regular monthly meeting of the Branch held on the third Wednesday in October. Elections shall be by secret mail ballot of the eligible Branch membership, held as soon as possible after nominations in October. All Officers and Shop Stewards shall be elected to a term of two (2) years.

Proposed Change:

Nominations for the election of Branch Officers, Shop Stewards, and Convention Delegates shall be called for at the regular monthly meeting of the Branch held on the third Wednesday in October. Elections shall be by secret mail ballot of the eligible Branch membership, held as soon as possible after nominations in October. All Officers and Shop Stewards shall be elected to a term of **three (3)** years.

Ozzie's Corner

As I reported at the March 15th general meeting, The Social Security Fairness Act (S. 597) was reintroduced in the Senate by Senators (D-OH) Sherrod Brown and Susan Collins (R-ME). Earlier this year on January 9th, at the start of the 118th Congressional term, the bill was introduced in the House. Garret Graves (R-LA) and Abigail Spanbereger (D-VA) were the pair of legislators. S.597 has 2 parts that are critical and need to be addressed, The Windfall Elimination Provision (WEP) and The Government Pension Offset (GPO). Under The WEP and GPO are parts of The Social Security guidelines that unfairly cut or drop The Social Security benefit to millions federal beneficiaries. Civil Service Retirement System Letter Carriers are vastly impacted under these provisions. On March 13th, we had our Region 12 Training Rap Session. During The General Session, Kori Blalock Keller (NALC's Chief of Staff and Head Lobbyist) addressed the delegates and assured them that passing this significant legislation is a top priority for our members. As of March 26th, there are 36 co-sponsors on the bill (including Sens. Booker and Menendez).
