### **Presidents Report**

I would like to take this time to wish everyone a very Happy and Healthy Holiday Season as we head into what could be our busiest season in a long time, which is a good thing. There are few things you need to keep focused on during this next month, along with delivering these thousands of packages. First is the issue of what the lame duck congress will do with postal reform. If you signed up as an e-activist, you received an e-mail from President Rolando stating what is happening behind closed doors, which is not good for us. He has asked us to call our representatives in the House and Senate to oppose any type of legislation this year. If you have not called yet, please continue to call your reps and ask them to oppose any legislation on postal reform until the New Year. The number to call is (202) 224-3121. We must stop this back-room deal before it gets attached to must-pass legislation, such as the "fiscal cliff" law or the Hurricane Sandy relief bill." If anything happens before our meeting, I will let your Stewards know. Secondly, our negotiations are still progressing on trying to get a new contract, and from what I have been told, it is possible we will hear something in January. I hope that we do, so we can move on and fix a company that is doing just fine in spite of our negative Postmaster General. Another issue we are dealing with is our offices being DUO'd into other installations. I stated last month that I would report on this waste, but being the Holiday Season, I decided to try to stay positive and let it continue to evolve before making my opinion heard. One last thing to remember is you will hear those from the district who will say that since the mail volume is decreasing the increased parcels should make up for the less delivery time needed! The problem with their rationale is we have 10 times as many parcels and scan able packages than normal, and they are clueless as to what mail we actually are delivering. We are delivering more advertisements than we have had in a long time. There may be some of our smaller offices who have "no mail" but that is not the case in our larger offices. Just remember your parcels and accountable mail are not captured in DOIS, therefore, you are not given the delivery time for those two functions. For those offices that have managers who continue to manage with DOIS, and not their brain, you know who you are and so do we, make sure you fill out your 3996, and determine what you need to complete your assignment. We are all professional enough to figure out the time needed to deliver our routes with these parcels. Also, remember on the form 3996 when requesting a reason for your needed time, just put in there the letter j, this section states we need no reason during the Christmas season! Have a Safe and Healthy New Year, and hope to see you at the Christmas meeting.

Drug Recall On Nov. 9, 2012, Ranbaxy Laboratories announced a voluntary retail level recall of multiple lots of Atorvastatin, the generic version of Lipitor® that were distributed between September 25, 2012 and October 26, 2012. Atorvastatin is prescribed in combination with diet and exercise to lower elevated levels of cholesterol and to decrease the risk of associated cardiac events. # **Grievance Log Step B Decisions**

Gibbstown-Management violated Article 11.6 of the National Agreement and item 13 of the Local Memorandum of Understanding (LMOU) when they did not follow the holiday scheduling procedures for the Columbus Day holiday. As a remedy the grievant will receive an additional premium of 50 percent of the base salary straight time rate for the improper scheduling.

Gibbstown- Management violated Article 5 of the National Agreement when they instructed carriers to stop a casual conversation when the conversation between the two was not interfering with their work and was not inappropriate or disruptive. As a remedy management is instructed to cease and desist! (This is a disgrace that we had to file this grievance, which tells you something about what is going on in this office!) Marlton- Management violated Article 19 and 41 of the National Agreement, Section 243.6 and 242.122 of the M-39 and section 911.2 of the M-41 by failing to properly review the adjustments made to route 31 in Marlton on June 30,2012 and make further route adjustments needed to achieve a route as near 8 hours daily work as possible. As a remedy management is instructed to make necessary adjustments to make route 31 as near 8 hours as possible within 30 days of the parties' receipt of this decision.

<u>Voorhees-</u> Management violated Article 41.1A.2 of the National Agreement when they did not post for bid the duty assignment (CR4320) of a carrier who was temporarily detailed to a supervisory position in excess of 4 months. As a remedy management is directed to post duty assignment CR 4320 for bid during the next bidding cycle

<u>Gloucester (Camden Annex)</u> - Management violated Article 28 of the National Agreement when they issued the grievant a Letter of Demand. As a remedy the Letter of Demand will be rescinded.

### Informal A

<u>Haddon Hts.</u> (Camden Annex) - Letter of Warning issued for Failure to Work in a Safe Manner/Unsatisfactory work performance. Reduced to time served (2 weeks) and rescinded.

# Misguided Compromise Proposal Misses The Mark

Sen. Joseph Lieberman (I-CT) has proposed an alarming idea to allow the U.S. Postal Service to end Saturday mail delivery service but retain package delivery service on that day. "While I'm sure Senator Lieberman's intentions are good, his proposal completely ignores the 2006 congressional mandate to pre-fund 75 years' worth of future retiree health benefits and to do so within just 10 years," NALC President Fredric Rolando said.

# **Retiree Cost-of-Living Adjustment (COLA)**

Following the release Nov. 15 of the October 2012 Consumer Price Index (CPI), the accumulation toward the **2014** retiree cost-of-living adjustment (COLA) is **0.5 percent.** Meanwhile, **the 2013 retiree COLA** will be **1.7 percent** under both the Civil Service Retirement System (CSRS) and the Federal Employees Retirement System (FERS), following the release of the September Consumer Price Index (CPI) on Oct. 16.
