# Presidents Report

Each December I try and make this month's newsletter as positive as I can, since this is a happy and joyous time of year for everyone. There are a few things I must mention, however, as we head into our busiest time of the year. I must remind everyone how your managers will try and take advantage of you when it comes to evaluating your daily workload during this busy time. We all know the number of packages we will be delivering this year will be astronomical, as the postal service has gone on record as stating they expect the package delivery to increase by 12% over last year's numbers. For those of you who want to know what that means is last year the postal service delivered 680 million packages during the peak delivery time and are expecting to deliver 750 million packages this year! What does that mean to you? It means you will be working harder than you did last year, and your managers will act like you won't need any extra time to deliver them. I kid you not, as I have been informed the district is trying to capture as much of the street time now, so they can once again try and convince you the under-time you have on your route will be more than enough time to cover the added time you may need for your extra hundred parcels. It is a shame I have to expose the district every year for their constant lack of respect they have for our craft. There are some managers that I talk to, who understand this time of year, who are having a hard time trying to justify this type of managing. They all know the carriers are working to their maximum effort, but the district continues to beat them up with their daily telecoms, even embarrassing some postmasters, because they are not making their bogus numbers. What a joke it must be to have to deal with all of this micro-managing.

I want everyone to be aware of your requirements when you will not be able to finish your route in 8 hours. This is taken directly from the M-41 handbook and it states," 131.41, It is your responsibility to verbally inform management when you are of the opinion that you will be unable to case all mail distributed to the route, perform other required duties, and leave on schedule or when you will be unable to complete delivery of all mail. 131.42 Inform management of this well in advance of the scheduled leaving time and not later than immediately following the final receipt of mail. Management will instruct you what to do. If you notify management they must either give you assistance or authorize you to work overtime. We are running into issues where managers are stating carriers are not filling out 3996's requesting assistance. There is nothing in the M-41 that states we must fill out a 3996 unless we are getting assistance. If we verbally notify them, we have fulfilled our responsibility. I suggest everyone have a witness to the fact you requested assistance, since we have many managers who are outright lying that carriers never informed them they would not make their expected times. Managers have been instructed not to give out 3996's to carriers, since they believe no route is ever over 8 hours! Please don't buy into this nonsense. Know your rights, and you won't have anything to worry about. We have noticed an increase of discipline being issued to carriers for not making managers expectations based on their "demonstrated performance!" As long as you verbally inform management you can't meet their expectations, you are covered. They will try and intimidate you into accepting their numbers, but don't let their phony system fool you. The increase in parcels you will be delivering will blow up their P.E.T. program. Stay safe out there and don't be forced into running around in order to meet their numbers. It takes what it takes.

That's my rant this month, sorry for not being as positive as I usually am. Also, I will have a lot of fodder to bring to you next year as we are experiencing some more nonsense in our Deptford Installation. Some things never change!

## **Comments From The VP**

I have a few reminders for everyone to keep in mind before the start of the New Year. First, the December Penalty Overtime Exclusion period begins Pay Period 25-16, Week 2 (Dec. 3) and ends Pay Period 01-17, Week 1 (Dec. 30). When filling out your 3996 you can put the letter J for your reason for auxiliary assistance. If your 3996 is denied call your office in the afternoon and get instruction from your supervisor. Don't argue with the supervisor if he asks something stupid like, "What's taking you so long?" Just ask if they want you to continue with your deliveries or do they want you to bring mail back. Just because your 3996 was denied doesn't mean that your mail will magically deliver itself, and it certainly doesn't mean that you should skip your lunch and breaks or work in an unsafe manner. Second, if management instructs you to finish your assignment in the dark then make an effort to follow that instruction. If you determine the conditions are unsafe then inform your supervisor that you will be returning to the office. You, the carrier, are the one that makes that determination. Third, the new program called P.E.T. (Performance Engagement Tool) is just a management tool and it does not change your reporting requirements (filling out 3996) nor can it be the sole reason you are disciplined. If anyone has any issues with any of the above, please contact me immediately. Next, I got our branch involved in a program this year for underprivileged children called the Angel Tree. Tags are placed on the tree representing these children's Christmas wishes. Donors pick a tag from the tree and shop for the perfect gift for the child selected.
