Health Benefits, MBA, FMLA, Optical

Hello Brothers and Sisters. Open season has officially closed. Hopefully all needed changes were made in time. Any changes from this point on can only be made for life, and career changing events. New hires have 60 days from day of hire to enroll in the USPS HBP.

The year is coming to an end so if you haven't already, anyone in the NALC HBP High Option if you fill out a Health Assessment you are entitled to one of 3 free gifts offered by the plan. When one covered member completes the HRA, you may choose one of the following:

Self only CignaPlus SavingsSM discount dental program;

Waiver of two \$20 PPO medical office visit copayments (when the Plan is the primary payor) incurred in the same year as the Health Assessment is completed; or

a wearable activity tracking device.

When two or more covered family members (including the member) complete the HRA, you may choose one of the following: Family CignaPlus SavingsSM discount dental program,

Waiver of two \$20 PPO medical office visit copayments (when the Plan is the primary payor) incurred in the same year as the Health Assessment is completed; or

a wearable activity tracking device (limit 2 devices per enrollment)

Go to nalchbp.org to complete the assessment.

With the new year upon us I urge everyone to look into all that is offered through NALC MBA. Various life insurance plans, hospital plus, retirement savings, and CCA savings, are all offered to us through MBA. Go to nalc.org under Member benefits to see the options. Start your tomorrow today at MBA. Optical: Any NALC 908 member in good standing is entitled to one per member/family optical reimbursement annually. For 2017 all receipts must be received by Saturday 12/30/2017 in order to be credited for this year. Ozzie's Corner

In November's Newsletter, I emphasized that the 2017-2018 proposed Postal budget is a clear cut direct hit on all active and retired Letter Carriers. The last four areas covered in this proposal produce serious consequences that need to be payed close attention to, another words, these are true and actual. Point 1, the annuity supplement that covers the gap for employees who retire under FERS before they qualify for Social Security benefits at the age of 62 would be eliminated. Point 2, The G Fund under the Thrift Savings Plan would slash the rate of interest paid on assets invested, costing active and retired Letter Carriers alike \$32 billion over 10 years. Point 3, \$46 billion in revenue changes and defined cuts to the Postal Service. The memo includes reducing the frequency of delivery (eliminating Saturday delivery) and scaling back door to door delivery. The last piece in the budget, to me is the worst, it would make the financially independent Postal Service into an "on-budget status". The USPS would see across the board spending cuts (sequestration). Also, service would be disrupted should the federal government shut down during these conflicts. However, through all of this doom and gloom, there is a solution to this horrific ideology, a light at the end of the tunnel: The Letter Carrier Political Fund. Investing and protecting your job as a City Letter Carrier costs as little as a dollar per pay period. In closing, I want to thank Pedro Rodriguez (Pennsville Office) for being this month's LCPF contributor and Ryan Schmidt for his assistance. I hope to see you all at the December meeting.

*(By making a contribution to the LCPF, you are doing so voluntarily with the understanding that your contribution is not a condition of membership in the NALC or of employment by the USPS, nor is it part of union dues. You have a right to refuse to contribute without any reprisal. The LCPF will use the money it receives to contribute to candidates for federal office and undertake other political spending as permitted by law. Your selection shall remain indl force and effect until cancelled. Contributions to the LCPF are not deductable for federal income tax purposes. Federal law prohibits the LCPF from soliciting contributions from individuals who are not NALC members, executive and administration staff, or their families.)
