Presidents Report

As we head into the busiest time of the year for everyone, I want to remind our newer employees, and even our seasoned veterans about a few items. First and foremost, please be extra careful when delivering the enormous amount of packages you will be getting this month, as many people are in a hurry to get nowhere but may put you at risk by their careless driving habits. I know many of the newer carriers may be overwhelmed with the amount of time it may take to complete your assignment, but please don't be intimidated to rush through your job by some of your overzealous and inexperienced managers! You have now been instructed to scan every package while loading up, which obviously will take more time on the street, even though you will hear some managers say the reduced mail volume makes up for the extra packages. Please don't buy into that nonsensical comment. You determine the time it takes, not their DOIS program, which does not take into account your additional parcels. Some offices, who have competent managers, which aren't many these days, "get it" but some will continue to try and manage by the computer. I suggest you stay in communication with your local managers when you are not going to make their morning expectations. Just remember, the postal service has already gone on record as stating the parcel volume will be up by better than 10% this year as compared to last year. Please be smart and take it safely, even if it means it may take longer.

One nice thing I wish to mention is the work of our stewards in Williamstown and Marlton, who with the help of our Business Agent, has gotten carriers grievance settlements totaling over \$10,00.00 for being screwed by local managers. The Williamstown situation dealt with time-card tampering which netted 11 carriers approximately \$1200.00 and a carrier in Marlton over \$9300.00 for being done wrong. The one downer to this good news is the manager who is guilty of these thefts in Williamstown is still employed in the postal service!

Another important item to report on is I have just been officially notified that a few of our offices will be having route inspections in the spring. The list is as follows: <u>Magnolia</u> and <u>Somerdale</u> are <u>March</u> 16th thru March 22. <u>Stratford</u> is March 23 thru March 29. Clayton and Glassboro are April 6th thru April 12th. Williamstown is April 13th thru April 19th. Gibbstown and Paulsboro are May 18th thru May 24th This is the most updated list as of now and may be changed or added too. As always, we will set up training classes for all offices as the dates approach, so please don't sweat not being prepared for this, as we will give you all the information you will need to make it a successful inspection. I know many carriers would rather make a deal than do a full-blown inspection, but for the offices who haven't been inspected in over 5 years, it really is to your benefit to get updated and fresh data going forward. Your routes have been using old numbers to measure what you do now, which isn't fair to anyone. Getting credit for all the extra duties you do today will benefit you in the future.

Lastly, I would like to wish everyone a **Merry Christmas and a Happy and healthy New Year**. Hope to see everyone at our December meeting for some wings and shrimp and a chance to win our attendance prize of \$250.00. Stay safe and be smart.

Only opportunity for changes now are qualifying life events (QLE), or a change in status, such as a conversion to career, or retirement. CCA's converting to career, and those about to retire, I urge you all to take a look at the NALC health benefit plan. You have a right to refuse to contribute without any reprisal. The LCPF will use the money it receives to contribute to candidates for federal office and undertake other political spending as permitted by law. Your selection shall remain in full force and effect until cancelled. Contributions to the LCPF are not deductable for federal income tax purposes. Federal law prohibits the LCPF from soliciting contributions from individuals who are not NALC members, executive and administration staff, or their families.)
