Presidents Report

Well brothers and sisters, I can say this January was as tough a month that I can remember in a long time. What really concerns me is how some managers can constantly question our member's ability to do our job under such difficult conditions. Walking and driving under icy and frigid conditions makes it a very challenging job. The stuffed shirts who sit in their cozy warm offices make me sick when they question the extra time the carriers need to get the job done safely and efficiently. I won't dwell on their lunacy since we all know what it takes to get the job done professionally and efficiently. Please do not be intimidated to do something unsafe because of their unrealistic expectations. I am sure some of the accidents we incurred last month were because carriers were trying to rush to get back. Remember, you will never be disciplined for being safe. There is no way you can predict how long your route will take under some of these tough conditions. If you have a manager who insists on a time before you leave for the street, I suggest you give him a professional assessment and then call back half way major issue we have uncovered in this district is the improper time card entries many, if not all managers are guilty of! We have seen four offices so far, who are putting carriers on improper codes, which in turn changes the times associated with their routes. The way we have found out these illegal maneuvers is through investigating grievances for overtime and one office that had a carrier just complete a special inspection. very troubling occurrence in my opinion. We have a memo from the district manager dated August 19, 2013 that speaks specifically of this type of behavior from his managers. He states that,"the integrity of postal systems programs and supporting documentation should not be sacrificed for operating expediency." He also states that, knowingly recording incorrect time for another employee constitutes falsification of a report. Any employee knowingly involved in such a procedure is subject to REMOVAL OR OTHER DISCIPLINE." are his words, not mine. I hope he is serious in dealing with this rampant problem. I can bet all managers are guilty of this in order to make their numbers. Let us see if he addresses our concerns. My bet is he is aware of what they are doing and will not even acknowledge our concerns. By uncovering these improper entries, I would say all route inspections that are pending this year will now be scrutinized by us big time. I can now see why these inspection teams think they can take out routes in many of our offices. If there are improper entries on routes it would lead those looking at numbers to think there is a lot of "under time" in offices. The reality of the situation is there is phony under time. When carriers are put on 737, 731,354 etc., it brings down the actual route time. This is why this type of managing has to be stopped. No one makes out on this kind of behavior. I will be having all my stewards requesting reports to see who is guilty. My guess is everyone is doing it. I hope they will be treated like we would be if we were guilty of the same infraction! Stay tuned to see how many rats start jumping ship!

The Postal Service has issued mandatory safety talks to be given to all employees regarding protection from cold temperatures. If management has not provided these safety talks, advise your supervisor, shop steward, branch officers or, if necessary, your National Business Agent. **Bottom line:** Do not put yourself in danger.

Retiree Cost-of-Living Adjustment (COLA)

There was **no accumulation** toward the 2015 cost-of-living adjustments (COLAs) for both Civil Service Retirement System (CSRS) and Federal Employee Retirement System (FERS) following the Jan. 16 release of the Consumer Price Index (CPI) for December 2013.

Grievance Log Step B Decision

<u>Blackwood-</u> Management **did not** have just cause to issue a Letter of Warning for Failure to Follow Instructions when he was charged with not notifying management he would be late on numerous occasions. The file shows grievant did call and verbally inform management he would need assistance. As a remedy, the Letter of Warning shall be rescinded.

<u>Blackwood-</u> Management **did not** have just cause to issue a 7 Day Suspension for Failure to Follow Instructions when he was charged with being belligerent and refusing to work. Based on the file management has not proved grievant acted as charged. As a remedy, the 7 Day Suspension shall be rescinded.

Gibbstown- Management violated Article 17 of the National Agreement when they refused to provide the steward time and access to interview 3 carriers on the clock, which resulted in the interviews being conducted off the clock. As a remedy, the steward will be paid 1.33 hours at the overtime rate, 1 carrier .33 hours OT and 2 carriers .50 hours OT.

Stratford- Management violated Article 19 of the National Agreement, specifically Section 432.712 of the ELM, when they disallowed overtime worked by the grievant. As a remedy, management is instructed to inform the carrier and the union of any time disallowance in the future prior to disallowing time it may believe to be warranted. No monetary remedy is appropriate in this case because the amount of work time is de minimis.

Stratford- Management violated Article 19 of the National Agreement when they improperly edited carrier's time cards by placing them on incorrect Management Operating Data Systems Codes in violation of the M-39 Section 126.42 and the M-32 Handbook. As a remedy, since the integrity of the data has been compromised, specifically MODS code edits, this data shall not be used for any route analysis purpose. Management is also instructed to cease and desist.

<u>Stratford-</u> Management violated Article 19 of the National Agreement, specifically Section 432.712 of the ELM, when they disallowed overtime worked by the grievant. As a remedy, the DRT will pay grievant for .19 units at the overtime time rate.

<u>Stratford-</u> Management violated Article 8.5.G of the National Agreement when they forced work assignment carriers to work overtime on other routes when the ODL carriers and a CCA were available to do this work. **As a remedy, 5 carriers will each be paid .50 hours at the overtime rate.**

IMPORTANT NOTE

In 2014, both of the deferred 2013 COLAs, \$146 annually and \$541 annually, will be added to the Step O pay rates in Table 2 of the Pay Schedule, which applies to City Carriers hired in career positions on or after January 13, 2013. The pay rates of Steps A through N of Table 2 will be increased proportionally, as provided by the contract. For example, Step A is set at 61.5% of Step O, so the COLA for Grade 1, Step A is \$333 annually.
