Grievance Log Step B Decision

Atco- Management did not have just cause to issue the Notice of Removal to the grievant on March 27, 2014 for "Improper Conduct." The DRT has stated management did not show the grievant engaged in "Improper Conduct" by willfully abusing her prescription medication as charged! Therefore management did not have just cause to issue the Notice of removal. As a remedy, the Notice of Removal shall be rescinded and based on the medical reports clearing the grievant, shall be immediately returned to full duty and made whole for all lost wages and benefits.

Blackwood-Management violated the M-39 section 211.1 when they failed to share the results of the route review with the carriers and the union prior to the route inspection conducted the week of April 5th, 2014. As a remedy, management is directed to share the work hour, volumes and possible deliveries data for each route from before the route inspection with the carriers and the NALC President so it can be compared with the route inspection/adjustment data.

Camden Annex Formal A

Bellmawr - Management violated ART 8 when they forced non-odl carriers to work. As a remedy odl carriers will share 25.19 hours at the overtime rate.

Fourth Contract Cola

Following the April 15 release of the March Consumer Price Index (CPI), the accumulation toward the fourth cost-of-living adjustment (COLA) under the 2011-2016 National Agreement is \$520 annually. This COLA will be based on the increase in the CPI between January 2014 and July 2014 and will be effective in the second full pay period after the release of the July 2014 CPI.

Retiree Cola

The accumulation toward the 2015 cost-of-living adjustments (COLAs) for both Civil Service Retirement System (CSRS) and Federal Employee Retirement System (FERS) was 1.4 percent following the April 15 release of the Consumer Price Index (CPI) for March 2014. The 2015 COLA will be based on the increase in the average CPI between the 3rd quarter of 2013 and the 3rd quarter of 2014.
