Presidents Report

Hopefully the weather will cooperate this month, as we had to cancel last month's meeting. I hope we got the word out to everyone in time to notify you of the cancellation. Well brothers and sisters, it appears the postal service may be implementing some new initiatives this year, so I wanted to keep everyone updated as to what they are planning. The first item deals with collection boxes assigned to collection routes that have a scheduled pick-up time prior to 3:00 pm. I am not sure how many of our offices have some type of collection routes, but I know there are a few that this may affect. The postal service will be reviewing these boxes to determine the feasibility of reassigning the collection boxes to a route in the immediate vicinity. Prior to implementing a change, local management will discuss the potential impact with the carriers involved. This is a study which will conclude at the end of April. If this is occurring in your installation, please let your steward know or contact me directly if they are doing this study in your office. The next item deals with a program the postal service plans on implementing and IS NOT A TEST! It is called the "The Arrow Key Initiative" This initiative places new responsibilities on letter carriers when they return to the office. The orders state the carriers are to deposit their keys and gas card into an envelope or bag. The directive then has carriers placing the envelope into a designated receptacle in their office. The Plan also includes a Non-Postal Form that management will try and have a carrier sign. Please be advised this process puts all carriers in a very dangerous situation in that no one will be verifying that you have completed the accountable clearance process. The consequences of this non-verifying process are the carriers will be blamed for loss of keys or gas cards, which could become a removable offense. I ask everyone to be vigilant in monitoring this process if it is brought into your installation. This is another violation of their own Handbooks and Manuals, and I ask you to do not sign anything in regards to this process. Please ask for union representation if they try and coerce you into signing anything. It amazes me on the constant programs this company tries to implement to catch carriers allegedly not doing their job! They need to concentrate on trimming the "Fat" of their managers, not constantly attacking the hardest working craft in the service! We are used to it, and we shall overcome their nonsense once again. The next issue I want to address once again deals with managers trying to have disciplinary interviews with carriers without the union being present. This information is for all those newer employees who may not know what your rights are when it comes to having pre-disciplinary interviews with a manager. I am sure some of your managers have said to you that "you don't need your steward, this is only an informal discussion" am I right? Please don't be fooled by this "nice gesture." There is a right called "Weingarten Rights." This right gives you the right for union representation during any investigatory interview. The supervisor MUST tell the employee and the steward the purpose and subject of the meeting before the meeting begins. We have many uneducated managers who think they can have an interview without telling you or the steward the reason for the interview. Please don't be fooled by this incompetence on the managers part. If they refuse you this information, please ask them to end the meeting immediately and contact me directly. This meeting also allows the steward to be an active participant and not just an observer. If this occurs, please end the meeting and contact me ASAP. Hopefully, this doesn't occur in your office, but I have been told it is going on in some installations throughout our district. Please read up on your rights and responsibilities in Article 17 of the JCAM so you can avoid any possible discipline by saying something you didn't know could hurt you. Hope to see you at this month's meeting.

Ozzie's Corner

On February 4th in Washington, D.C., U.S. Representatives Joe Courtney, Suzan DelBene, Mike Kelly, Elise Stefanik along with New Jersey Congressmen Chris Smith and our very own Donald Norcross introduced House Resolution 748. H.R. 748 is about repealing 40% of excise tax on certain employer sponsored health insurance plans known as the "Cadillac Tax". The "Cadillac Tax" would affect employers and families whose health insurance plans cost more than \$11,100 for an individual and \$29,750 for family coverage. 300 members of Congress from both parties have cosponsored legislation to repeal the 40% tax. Con. Norcross is no stranger to negotiating worker health benefit packages and fighting for hard working families, he did that for many years as a former IBEW and SJ AFL-CIO leader. By the way, from day 1 since he has taken office, he is a fighter for Letter Carriers too. Con. Norcross has signed on to all of our House Resolution Bills (6-day, Door to Door, Service Standards and most recently Privatization). In addition, I have seen him take part in our postal rallies and he is a strong supporter of our veterans. The legislation on H.R. 748 has gained support from many organizations including International Brotherhood of Electrical Workers (IBEW), American Postal Workers Union (APWU) and our own NALC. I want to personally thank you Con. Norcross for the job you continue to do representing hard-working blue-collar people.

In other news, I want to thank March's LCPF contributors of Branch 908: Active Member Joe Townsend (Gloucester City), Retirees Rick Bacon (Bridgeton), Don Connelly (Bridgeton) and Gary Stevens (Voorhees). Also, we had Life Member Howard Foxwell Jr. (Penns Grove). Remember, contributing for as little as a dollar per pay helps protect Letter Carrier jobs, pay, benefits and pensions. Lastly, I want to thank each and every member who contributed to LCPF in 2018. In February's Postal Record, once again we went up for the fourth year in a row in branch percentage (26.9).
