Presidents Report

It looks like the cash just keeps flowing into everyone's paycheck, as our latest COLA has just been announced, and it stands at \$1331.00, which equates to \$.64 cents an hour. This next raise will show up in your March paychecks. This is the 5th of seven COLA's that are part of this agreement. If anyone is counting. the total amount of these raises is now at \$4035.00, which breaks all records, with two more to go. Based on how this economy is reeling, I see no reason why these raises won't surpass the five-thousand-dollar mark by the time they end. Also, the retirees next COLA now stands at 2.9%. Next, as our COVID cases are starting to drop immensely, the memo's we have had in place for last the last 2 years are still active and have been extended to April 8th. It is finally nice to see we are starting to get back to some kind of normalcy and hopefully we will see many of the restrictions be lifted for good. We can't be complacent however, and it's always good to be making sure we all do the right things when we can. Next, we are having our Retirees banquet again this year and it is fast approaching. It will be April 2nd this year, and we will be honoring a lot of new retirees. Check the newsletter for those we will be honoring. I hope you come out this year and help us celebrate those new honorees. It is a great time for a reasonable cost. Next, I know some of you are seeing managers walking routes, but this is nothing official, and is only done for management's satisfaction. It appears the POOM is forcing managers to walk with carriers who aren't making their office numbers. The problem with this style of harassment means nothing to us and can't be used for anything. Just remember, one day counts do nothing to affect your route and the numbers they use when they count you are useless. Please don't be fooled by managers saying you are not making your office numbers. If management really wants to get a true picture of a route, they need to do a full 6-day count. Just so you know, there will not be any unilateral formal inspections coming as the national parties are working on a joint process for the next rounds of inspections. Next, if you haven't heard, the Postal Service Reform Act has passed the House and heads to the Senate for confirmation. Hopefully, by the time you read this the Bill will be passed. Just so you are aware, this bill, when passed, won't go into effect until 2025. Read LCPF chairman Ozzie Lecky's report for all the details. Next, for those PTF's we have on board, I wanted to update you on an issue our National Union is addressing on your behalf. It appears the postal service was miscalculating their method of calculating overtime pay, Sunday premium pay, general wage increases, and COLA adjustments in Step AA. I won't get into all the details, but the bottom line is this; You should be getting \$29.82 at the overtime rate, but they are paying you \$28.67 an hour. For the Sunday premium rate, you should be getting an additional \$4.97 an hour but they are paying you \$4.78. For those of you who this affects, you don't have to do anything. As our leaders are working to get this fixed. Hopefully, it will get resolved quickly and you will get back pay for the money you were screwed out of. I will keep you updated on the progress of these talks. Also, this year we have an unusual occurrence in that we have 27 pay periods instead of the usual 26. What this means to everyone is that you will earn an additional pay period's

worth of leave. Depending on your category, it will be either 4,6, or 8 hours. CCA's are credited with 1 hour for every 20 hours they spend in a pay status during each biweekly pay period. It will end on January 13, 2023. I am letting everyone know in case you are in a use or lose category. The leave carryover limit will not go up because of this, so make sure you adjust accordingly. Lastly, we will be attending our Region 12 training seminar this month in Atlantic City and I will have the latest information to share with you at this month's meeting as our National President Fred Rolando and Executive Vice-President Brian Renfroe will address the membership. Hope to see everyone at this month's meeting. Stay safe.

Ozzie's Corner

ALL TIME 908 HIGH !! If you haven't checked February's Postal Record (The LCPF Edition), starting at the bottom of page 58 and going over to page 59 lists all of our members (active and retired) who contributed to our national pac in 2021. If you recall last year for our year 2020 campaign, we missed our 200-member contribution goal by 1(199). In 2021, we completely shattered the 200-goal threshold with 214 contributors (ALL TIME BRANCH HIGH PER CAPITA). Furthermore, we hit a new branch yearly contribution percentage (28.3%). For fun, I crunched the total of the 214 and did a membership breakdown for every category. 151 of our 2021 contributions came from Active Members (71%), 52 of our contributions came from our Retirees (24%) and 11 came from our Life Members (50 Years or more of union membership, 5%). In 2019 and 2020 our percentages were 26.8 and 27.1 respectively. However, we jumped a full whole percent last year and it is because of one reason and one reason alone, the members in this branch. I want to personally thank every member of 908 who gave to LCPF in 2021. The commitment each one of you pledges every week, month and year donating to our union's political fund is the reason why we are winning every legislative battle that has to do with City Letter Carriers. Even though we still have more work to do, please take the time and enjoy our phenomenal branch victory!

Speaking of a victory, we won the first legislative part of HR 3076 (The Postal Service Reform Act) on February 8th. In an overwhelming vote of 342 to 92 in the House of Representatives, we are one step closer to winning three key battles in this bill. Immediately 2 days later (February 10th), The NALC broadcast on their homepage online at NALC.ORG a Senator Action Alert. Members across our country are urged to call 1-844-959-1425 and leave a message on the Senator's voicemail and/or by speaking with one of the Senator's staff representatives. What you can say is this, "Hello, my name is (blank). I am a Letter Carrier for (blank years or I am retired from The Postal Service) and I urge you to please vote yes on HR 3076". If you feel extra informative, tell them HR 3076 does 3 things: eliminate the pre-funding mandate, make 6 day delivery permanent and maximize Medicare for Postal Employees. In New Jersey, our 2 Senators are Cory Booker and Robert Menendez who you will contact. The 1st or 2nd week in March is when the most important bill to date will be brought to the senate floor and we must take action and do our daily lobbying. 60 votes is all we need and then we can say goodbye to this 16 year Postal Service financial burden (The Mandate).

Finally, I want to thank March's LCPF contributor's: Jennie Feyt (Atco), Phil Haas (current Sgt. Of Arms, Westville), John Lowery Jr. (Woodstown), Loretta Morris (Gibbstown) and William Morris (Salem)..all Retirees!
