

## **Presidents Report**

This month I will give you an update on the issues you have been asking about since we discovered time-card fraud in a couple of our installations, specifically Elmer and Pennsville. I have been patiently waiting an answer from the District Manager, who stated most tersely in an e-mail response to me when I questioned him on the status of his investigation. He responded to me on October 4, which was 2 weeks after our meeting, which I thought was sufficient time to come to a decision, where he stated he was still investigating the issue and was offended that I would think he was dropping the issue. Well, a phone call or e-mail to me saying that would have been nice, but I guess I am not on his level to expect a response on such a serious matter. Anyway, after receiving his response, I told everyone I would give them a little more time to finish their investigation, even though we provided them with everything they needed. Well, it has been 4 weeks since I contacted him, and no one has contacted me in regards to this situation, which leads me to the only conclusion one could come to. They have allowed this manager to continue his career, even though he committed fraud by stealing money from CCA and career employees. This tells me the postal service will allow its managers to take whatever means possible to get the numbers for the "doctor!" They can sit there in their little rooms and say they have taken measures to correct this situation, but if that is the case, why is this guy running the Penns Grove Post office. This man should have been removed; just like a craft employee would have been had they committed a similar offense. We work for the biggest bunch of hypocrites. They brought in a slew of managers and the POOM to observe him in the office. Now you tell me this isn't a time wasting practice. Hey, it's OK for them to waste money, but God forbid the real workers need a few extra minutes to get the job done. This brother comes to work all the time, but they would rather sit him home then have him come in and do his job. He went to the postal doctor and passed his fitness for duty but that wasn't good enough. He then went to his own doctor for additional documentation and was cleared as well. Bottom line here is management is discriminating against an Air Force veteran who is 58 years old but can't give them their bogus numbers. The entire district knows who we are talking about and should be ashamed of this disgraceful

behavior. The brother got 30 days paid vacation because the district thought they could get him removed from his letter carrier position. How did that idiotic plan work out for you? I am sure the DM won't pursue the guilty players here because he was the leader of this travesty. Stay tuned for a lot more nonsense coming your way. In the fight.

#### **Comments from the VP**

First, I would like to wish all our members and their families a Happy Thanksgiving. I reported last month that the Mail Handlers Union had won \$7000 in grievances for management doing craft work, well I was informed by a reliable source that the number is \$17, 000, sorry for the typo. Daylight savings time ended on November 5, which means some of us will be working in the dark. I want to remind everyone that if management instructs you to finish your assignment in the dark then try to follow that instruction until you feel that an unsafe condition exists. You, the carrier, are the one that makes that determination. If you determine the conditions are unsafe then inform your supervisor that you will be returning to the office. We deserve and have the right to a safe working environment as provided under article 14 of our National Agreement. Now to the Camden Annex aka the Hell Hole. Haddon Heights and Gloucester are currently undergoing the route inspection process because they have auxiliary routes. This process as far as I know is to adjust the routes to as close to 8 hrs. as possible. However, from what I have learned so far from this inspection process is that if your route does not need to be added to but in fact needs something taken off to get to 8 hrs. then they cancel the inspection. Yes, that's just what they did to our Haddon Heights Office they cancelled the inspection 3 days into the inspection because some MINION from the district didn't like the fact that the numbers showed the routes in Heights were going to need cuts not additions to their routes. Now, how do these dishonorable actions affect us you might ask. Well, they contribute to the very things I have been saying in article after article about this deplorable Hell Hole, Harassment, Fake Numbers, Intimidation, Low Morale etc. I did find it interesting that a member of the route inspection team has been found by our shop steward in Elmer to have been deleting time from carrier's clock rings on more than a few occasions. I will

definitely have to go over the 1838's that he did during the inspections with a fine-tooth comb. Gloucester is undergoing inspections as I write this article will have an update on their results next month. **Proud to be union.**

## **Ozzie's Corner**

At October's general membership meeting, I discussed the 2017-2018 Postal budget proposal to the members in attendance that evening. The highlights in the proposal shouldn't be taken lightly. The cuts and threats in this memo are totally real. I will give 4 points in this article and 4 in next month's newsletter. Point 1, the administration wants to raise federal employee's pension contributions by up to 6.45% of their pay over the next 6years (costing active Letter Carriers up to \$3600 per year). Point 2, COLAs (cost-of-living adjustments) for current and future retirees under FERS (Federal Employees Retirement System) would be removed. Point 3, COLAs for CSRS (Civil Service Retirement System) would be reduced to 0.5% each year for annuitants. Point 4, pension benefits for new retirees under CSRS and FERS would be reduced by basing the annuities on an employee's highest average pay over 5 years (high5) instead of over 3years (high3). As you digest half of what you just read, this is why our national union has The Letter Carrier Political Fund. This national pact is in place for 1 thing and 1 thing alone, to destroy idiotic ideology like this. One dollar per pay period is all it takes to protect all the keys in this broad spectrum, I can be reached anytime for Legislative assistance or questions about LCPF at (856) 220-8658. \*(By making a contribution to the LCPF, you are doing so voluntarily with the understanding that your contribution is not a condition of membership in the NALC or of employment by the USPS, nor is it part of union dues. You have a right to refuse to contribute without any reprisal. The LCPF will use the money it receives to contribute to candidates for federal office and undertake other political spending as permitted by law. Your selection shall remain in full force and effect until cancelled. Contributions to the LCPF are not deductable for federal income tax purposes. Federal law prohibits the LCPF from soliciting contributions from individuals who are not NALC members, executive and administration staff, or their families.)
