### **Presidents Report**

I would like to take this time to thank the membership for their support in voting me, and the entire Board of Officers, to another two-year term at last month's meeting to represent the Bill Revak Branch 908 members. Once again, in these trying times I pledge to do what I have always done, which is to fight for everyone's rights and make this branch a successful and respected branch throughout this union. With that said, with all the new employees continuing to come on board, it is very important that you take an active role in seeing how your union, locally and nationally works, and that starts by regularly attending our monthly meetings on the 3<sup>rd</sup> Wednesday of each month. It was nice to see such a huge turnout at last month's meeting, and I hope this trend continues going forward. Next, we held our retirees banquet last month, and although it was held in the fall this year, due to COVID from the past year, it was a great night for all those who attended. I would like to thank our congressman from the first district, Donald Norcross, who graciously showed up to speak to those in attendance, which was a pleasant surprise for all of us. He just didn't say a few words and leave, but stayed for a while and talked with everyone. Thanks again congressman. Next, as we head into our busy season, I would like to prepare our newer employees on a few things. There will be managers who will try and pressure you to make your normal route times every day in the coming months, even though your parcel numbers will increase tenfold. Please remember that if your route averages 30 packages a day and you are now delivering a 100 or more, your street time will increase by a whole lot! Don't be fooled by your manager stating your mail volume is down, so it is wash. That is the oldest ploy going, so don't be intimidated to put in a 3996 for the additional time you think you may need. Remember, you determine how much time your route will need, not the DOIS program or PET program, etc. they will come around with. I have once again been notified that some carriers are not taking comfort stops on the street, but are doing things they shouldn't be doing, and you know what I am referring to. Please take the time to go a clean and comfortable place to take your comfort stop, because you are allowed to do that, and can go wherever you feel comfortable. Don't allow your manager to force you to go to a place that is not in your comfort zone. Also, with clocks going back an hour for daylight savings, we will all be facing the situation of working in the dark. Please remember that darkness by itself is not a safety issue, but if you cannot make a delivery in the dark safely, please do not attempt to deliver the mail. Make sure you notify your manager that you couldn't make that delivery because it was unsafe. I always get call this time of the year where carriers brought back the entire back portion of their route because it was too dark to deliver. I tell everyone that if you must dismount park and loop deliveries in order to deliver it safely, then that's how you must deliver it. Unless your manager tells you differently, please do what you must to deliver the mail safely. Of course, this will take you longer and you can put that on your 3996 as well. In continuing to keep everyone updated on our raises, the next COLA now stands at \$208.00 with no end in sight. The retirees COLA will be 5.9% in January, which again is a record for those retired. For those who retired during the year, your COLA will be prorated from the month you retired, so unless you retired last December, your COLA will be different than those who have been retired for over a year. Also, this November 20<sup>th</sup>, everyone will see another 1.3% raise in their salary, so the money just keeps building. I hope to see everyone at this month's meeting and please feel free to bring any of your issues or concerns to the meeting. Stay safe and have a Happy Thanksgiving.

### Ozzie's Corner

EVERY BLUE-COLLAR UNION JOB HAS 1! The question you are probably asking at this point is what Ozzie? The answer is a political and legislative action plan. I recently did some research on 3 major unions: International Brotherhood of Electrical Workers (IBEW), Transport Workers Union of America (TWU) and The United Steelworkers (USW). I will cover 1 in this month's article and the last 2 in December's Newsletter. Founded in 1934, The TWU currently has 150,000 members in occupations that cover the airlines, railroads, transit, etc. The political action The TWU conducts is called COPE (Committee on Political Education). Just like LCPF: A. COPE does not and cannot use members' dues for political activism. B. COPE is used to educate and inform candidates at all levels of government who support the TWU, regardless of party affiliation. C. COPE has a payroll contribution deduction program (similar to Postalease with your paycheck allotment). In addition, active members who don't wish to use a COPE program payroll deduction, can do a 1x annual contribution. Retirees in the TWU are encouraged to do 1x contributions too. Before I forget, any member who wishes to do a 1x to our pact, you can by making your payment out to the following: The Letter Carrier Political Fund or LCPF. The 1x payment can be made with a check or money order. Therefore, political contributions made out to Bill Revak Branch 908 South Jersey Letter Carriers or NALC Branch 908 cannot be accepted.

On October 10th, we had our branch retirement banquet in Gloucester City at Elizabeth's Ballroom. The keynote Speaker was Congressman Donald Norcross. Among his many subjects he touched on, he first and foremost thanked all City Letter Carriers for the outstanding job they have done and continue to do since day 1 of the COVID-19 pandemic. Furthermore, he emphasized that in order for the Postal Service to start a better path to financial success, it starts with slashing the problematic Pre-funding mandate. Time and time again, Congressman Norcross continues to have our backs supporting hard working men and women in the Garden State.

\*(By making a contribution to the LCPF, you are doing so voluntarily with the understanding that your contribution is not a condition of membership in the NALC or of employment by the USPS, nor is it part of union dues. You have a right to refuse to contribute without any reprisal. The LCPF will use the money it receives to contribute to candidates for federal office and undertake other political spending as permitted by law. Your selection shall remain in full force and effect until cancelled. Contributions to the LCPF are not deductable for federal income tax purposes. Federal law prohibits the LCPF from soliciting contributions from individuals who are not NALC members, executive and administration staff, or their families.)
