## Grievance Log <br> Step B Decisions

Salem- The DRT has resolved this grievance by determining that the Notice of removal had no effective date for the removal and the charge to the grievant was vaguely stated. Furthermore, it was the concurring management official who reviewed the discipline at both the Informal and Formal A steps, thus denying the grievant an independent review of the discipline at each level. Therefore, without addressing the merits of the case, the Notice of Removal shall be rescinded.

## Step A Decisions

Gibbsboro- The Letter of Demand issued to grievant is rescinded. No violation of Article 28.
Gibbstown- Management violated Article 8 of the national agreement. As a remedy 4 carriers to receive $\$ 30.00$ for this violation of working non-otdl carriers.
Gibbstown- Management violated Article 8 of the national agreement. As a remedy 3 carriers to receive $.82, .80$ and 1.38 hours at the overtime rate for working non-otdl carriers Gibbstown- Management violated Article 8 of the national agreement. As a remedy 3 carriers to receive 1 hour at the overtime rate and 1 carrier to receive .50 hours for working nonotdl carriers.

## APWU, USPS Negotiate Retirement Incentive

 Employees to Receive $\$ 15,000$ in Two Installments The APWU reports: "The incentive will be offered to eligible full-time employees who terminate their service through retirement, early retirement, or voluntary separation. Eligible part-time employees will receive a prorated amount. Most fulltime employees will have a separation date of Jan. 31, 2013. To allow sufficient time to provide accurate retirement estimates, part-time employees and employees occupying Non-Traditional Full-Time (NTFT)assignments of less than 40 hours per week will have a separation date of February 28, 2013. ## Postal Service in the red while U.S. House says 'Return to Sender' on Reforms

Imagine this scenario: An American business with a workforce the size of Wal-Mart defaulted on a $\$ 5.5$ billion payment to its creditors in August, and defaulted again last weekend. On top of that, the company is losing $\$ 25$ million a day. Nightmare? Sadly, it's the hard reality facing an institution that has been a critical part of our nation's fabric for more than 200 years - the United States Postal Service. The Postal Service faces serious challenges due to the recent economic slowdown, online competition, and congressional inaction. Unless Congress acts to help fix the problems, the universal mail service that Americans rely on - a service that supports a $\$ 1$ trillion mailing industry and some 8 million jobs - will be in jeopardy. Five months ago, the Senate passed a bipartisan, comprehensive bill - the 21st Century Postal Service Act - to prevent these historic defaults by right-sizing, modernizing, and reforming the Postal Service. It wasn't easy, and the Senate bill isn't perfect, but most Senators recognized that we have to act now to save such a critical part of our economy and a key engine of our ongoing recovery. The bill passed by a vote of 62 to 37 . In contrast, Republicans pushed through the House Oversight Committee their version of a postal reform bill on a strictly party-line vote nearly one year ago. House action stopped there, however, and the bill has languished ever since. Despite claims that they have enough votes to pass their bill, Republican leaders have refused to bring it to the House floor for a vote, forcing the Postal Service to default for the first time in its history. This inaction has prevented progress on a solution to address the Postal Service's challenges, it has eroded confidence in the Postal Service's future, and it has impaired the ability of Congress to implement reforms. That shouldn't happen, and it doesn't need to happen. Unfortunately, House Republican leaders have decided to delay any further consideration of postal reform legislation until after the November elections. Every day the House fails to consider a bill, the challenges facing the Postal Service grow more difficult and more expensive to resolve. Simply put, continuing to ignore the Postal Service's woes is fiscally irresponsible. We still hope that Republican House leaders will step up and do their part to help fix the serious, but solvable, financial challenges facing the Postal Service. We're ready to bring our ideas to the table and work out our differences in a conference committee. Members of Congress from both parties believe we can and should come together and do the right, responsible thing. We urge House leaders to do so quickly so we can preserve the Postal Service for future generations.

## Postal Regulator Questions USPS Consolidation Efforts

9.28.2012 - The Hill reports: "The Postal Regulatory Commission said Friday that its models showed the savings could be much lower than the $\$ 2.1$ billion predicted by USPS, and that the Postal Service could make consolidations that would not delay by as much when mail is delivered. In its Friday advisory opinion, the PRC said that the consolidation process could save as little as $\$ 46$ million a year, with $\$ 2$ billion in savings possible if all of USPS's assumptions bear out."
