#### **Presidents Report**

Happy New Year everyone. As we head into the new year, we will be facing many hurdles in the months ahead. The first issue, and the most important one deals with our waiting on a new contract. Hopefully, we won't have to wait too long for the arbitration decision, since there won't be the usual delays of trying to get the postal service to agree on a new agreement with stall tactics they like to use, since we are heading directly to a hearing. Hopefully, the decision will be resolved by the spring or early summer. The next issue we are patiently waiting on is the arbitration decision on the consolidated casing initiative. We have witnessed the utter failure of this process in our Marlton installation, and we should be hearing of this decision shortly. Another issue we will be waiting on as our contract becomes finalized is the national dispute on the Safety Captain/Safety Ambassador Program. When this program was started unilaterally by management, the union decided to cease working jointly with management, since the program gave us no say on who would be chosen as a Safety Captain and had many problems which could divide the work-force. Understanding the importance of safety, especially in our district, which ranks near the bottom nationally, our Business Agent, David Napadano and the District Manager, James Drummer, have agreed with continuing the principles and expanding the participation of the current Safety Captain program. There will changes to the program that we originally had wanted for this program. The Union will have the right to choose its representatives in the program and the observations made by these captains cannot be used in any way for discipline. We have always stated that safety is the most important part in our daily work life, but management never wanted to do it in a fair and joint way. Hopefully, with a new contract we can get back to working together with management for the betterment of our members, and this local agreement is a good start. I will keep everyone updated as I get more information on this program. The next issue that I became aware of during the heavy holiday season was how management was soliciting carriers to work less than their 8-hour guaranteed time when working a non-scheduled day. Let me quote from our contract, The Step 4 settlement H4N-2D-C 40885, November 14, 1988 (M-00879) provides that "Management may not solicit employees to work less than their call-in guarantee, nor may employees be scheduled to work if they are not available to work the entire guarantee." Please don't be fooled or agree to work less than you are guaranteed to receive, even if that's all you really want to work. Those provisions were put in the contract to protect you from managers trying to save a buck at our expense. If you can't commit to 8 hours, don't accept this improper offer. I have instructed all stewards to file grievance on behalf of those carriers who have "waived" their guarantee. The only way to waive a guarantee is if you became sick or had a personal emergency occur while you were working. One other item I would like to mention that concerns our Gold Card members. When you reach your 50 years in membership, your dues are waived, and you no longer have to pay to stay a member. You deserve that for the milestone you have reached. Lastly, we will be having the installation of all officers at the January meeting. Our National Business Agent, David Napadano, will be there to install the officers for their next 2-year term. Hope to see everyone at the meeting. In unionism!

The Postal Service, in compliance with OPM, has gotten rid of the paper versions of the OPF (Official Personnel File), the files are all digital now and you can view your file from your home computer. Go to the eOPF website at https://eopf.usps.gov/eOPF/jsp/essLogin.jsp. Once there, you will need your EIN (Employee Identification Number), this is the number on your pay stub, and your USPS PIN number (the same one you use for Postal EASE). If you forget your PIN, call 1-877-477-3273 and follow the prompts to have a new PIN mailed to you. Once you log in you can view and print anything in your file. If you find something that should not be there, contact your Shop Steward. I know this sounds like a broken record, but I would like to remind all our active members to serve their routes in a safe and professional manner. Do not be bullied by management and their projections to run thru your route. Take your lunch and breaks and take the time that is necessary to complete your route safely. I want to encourage all our members and especially our CCAs to try to attend our monthly meetings. It's your chance to get some important information on things happening in the branch and most importantly to ask questions or voice your concerns to your elected officers. Norm realized he couldn't run the race no more, but he was damn proud that I showed interest in doing this difficult job for our branch. In my first 2.5 years, at least once a month, I would keep him updated on what was going on with our branch numbers and percentages. Needless to say, he was elated and overjoyed. However, the joy turned to sadness in May 2017 when he passed at the young age of 91. Norm fought his health issues for as long as he could and that is what a union is all about. ### Grievance Log Step B Decision

<u>Elmer</u> - Management had just cause to issue corrective action for Improper Conduct/Failure to follow Instructions, however the team agrees the 14-Day Suspension was punitive in nature and reduces the suspension to a 7-Day suspension to be removed in 1 year from date of issue.

<u>Sewell</u> - Management violated Article 17 of the National Agreement when they failed to provide sufficient time to the steward for grievance handling. As a remedy, the steward will be compensated a lump sum payment of <u>\$1500.00</u> for the time spent processing grievances off-the-clock.

<u>Stratford</u> - Management violated article 8 of the National Agreement when non-overtime desired list carriers worked overtime before maximizing the ODL carriers. As a remedy, <u>1</u> carrier to receive .50 hours at the overtime rate.

<u>Stratford</u> - Management violated article 8 of the National Agreement when non-overtime desired list carriers worked overtime before maximizing the ODL carriers. As a remedy, <u>4</u> <u>carriers will receive 2.33 hours at the penalty overtime rate.</u>

<u>Stratford</u> - Management violated article 8 of the National Agreement when non-overtime desired list carriers worked overtime before maximizing the ODL carriers. As a remedy, <u>1</u> carrier to receive .22 hours at the overtime rate and 1.33 hours at the penalty overtime rate.

<u>Stratford</u> - Management violated article 8 of the National Agreement when non-overtime desired list carriers worked overtime before maximizing the ODL carriers. As a remedy, <u>2</u> carriers to receive .45 hours at the penalty overtime rate.

<u>Stratford</u> - Management violated article 8 of the National Agreement when non-overtime desired list carriers worked overtime before maximizing the ODL carriers. As a remedy, <u>1</u> carrier to receive 2.50 hours at the penalty overtime rate and <u>1 carrier to receive 1 hour at the overtime rate and 1.50 hours at the penalty overtime rate.</u>
