Presidents Report

We finally got one last raise from this contract, and it was the final COLA of \$208.00, which carriers will see effective March 11th. You have to say we did extremely well during this last contract, and hopefully, we will continue to see pay increases going forward in our next agreement. Speaking of our next contract, negotiations have begun effective February 22nd, with our new National President, Brian Renfroe, opening up talks with the Postal Service. You can view his video opening remarks on the NALC website to see where he is focused on getting the best agreement for all carriers. I believe we are in good hands with our new regime of union officers, as they have been trained by some of the best officers we have ever had. We will also see if the postmaster general is serious in working with us to get his 10-year plan to become a reality. He needs to work with us if he wants this to succeed. We will know very shortly where his head actually is. Stay tuned. Next, I want to let everyone know how important it is to know your rights about your job. It appears management has once again taken a position of trying to eliminate, or drastically reduce, the times carriers take during their contractual allowed comfort stops while out on the street. Just so everyone knows, this isn't a new fight, but it seems every time we are in a route evaluation process, comfort stops are the first item management tries to attack. I am going to constantly repeat to everyone that you are allowed "reasonable" time on the street to take comfort stops. Please make sure you take these comfort stops as you need them. For those who aren't aware how this impacts your route, the time you take for comfort stops is built into your street time when they evaluate your route. If you don't take them, you will not get credit for them. This is very important for everyone understand when the team comes to your office looking at your route. The next item I want to explain to everyone is where you take your lunch and breaks. You must identify these spots in your route book on your 1564. The times you take them may be different each day, but identify when you take them on a normal day. Next, we will be going to arbitration this month on the secondary mail in the DPS. I'm expecting to get a favorable decision, as this has been successful in all of our cases our national has taken to the hearing. This will be a huge win because it will give our routes some much needed office time. This is one case management is cringing about. We all know how much they want to get us out of the office as fast as possible. This will give a lot of caseable mail back to those routes who fight it every day out on the street. Let's hope we prevail. Another grievance we filed in many of our offices dealt with the package delivery during the year where management created x-routes or static routes and didn't give routes the credit for their parcels. We have won every one of those grievances, and management is instructed to stop this practice and give routes credit for their parcels. If your office continues to try and do this, please let me or your steward know so we can start asking for punitive damages going forward. Another thing I want to keep everyone abreast of is the creation of these new supercenters the postmaster general is looking to get rolling. There is a rumor that central jersey is going to be the first one in our state to get one. It should be very interesting to see how this plays out, so keep your eyes open for these buildings to start popping up! Lastly, the NALC is

updating the Letter Carrier Resource Guide, which will be available shortly through the member only portal on the NALC website. If you haven't registered yet, please do, so when they are available you can get a free copy mailed directly to your home. This guide is the best piece of literature the NALC has to offer its members. It has everything you need to know about your job and your rights and anything you can think of. Our union spares no expense when it comes to educating its members, so get yourself registered to get one. I will have more info to share at this month's meeting as we will be attending our region 12 training seminar in AC this month, where President Renfroe will be addressing the membership on the latest information. Hope to see you at this months' meeting.

Ozzie's Corner

Congratulations 908!! In February's Postal Record (The LCPF edition) we broke a new branch record in 2 categories, branch percentage and branch per capita. Found on page 66 of The Postal Record; Branch 908 end the year at 29.6% for the year 2022. The 29.6% was the second straight year eclipsing over 28% (28.3%: 2021) and the third straight year over 27% (27.1%: 2020). The Garden State is always represented well when it comes to contributing to our national PAC (Political Action Committee) and it was well represented again by branches up and down the coast in New Jersey. Among the branches that had a contribution percentage over 20% were Cherry Hill/Haddonfield: Branch 769 (31.6%), Cranford: Branch 754 (39.13%), Elizabeth: Branch 67 (20.19%), Freehold: Branch 924 (23.12%), Jersey City: Branch 42 (21.39%), Linden: Branch 2876 (43.42%) and Scotch Plains: Branch 4102 (35.71%). The branch membership in these locals vary considerably, therefore the smaller your membership of people and the more of them you have who contribute= a higher percentage in your branch. In Branch 908 the 29.6% at the time was calculated by us having a total of 771 members (Active, Retired and Gold Card) at the end of 2022. The new per capita we hit was 228 contributors. In 2022, Branch 908 had a goal of reaching 225 members giving to The Letter Carrier Political Fund, so by simple math we crushed our mark by 3. By accomplishing this historic local victory, we reached the 200 level the second straight year (214: 2021). I want to take this moment and recognition to thank each and every member in Branch 908 for making this happen. The selfless and voluntary attitude every member has in contributing to our fight as City Letter Carriers continues to astonish me and makes me equally proud to continue to fight as the Legislative Leader for Branch 908

Speaking of numbers, On January 30th I received an important letter in the mail from newly elected National President Brian Renfroe. Among the topics he addressed in his January 12th dated mailing, was our national LCPF percentage. Out of 290,000 total members, 10% contribute to LCPF. I don't know what is more shocking and disappointing, that nearly 30,000 members give or the 260,000 who don't! We must continue to stay together and united when it comes contributing to LCPF. To me, you start at home. Local Branch Presidents across the country need to start appointing (if they haven't already) LCPF Coordinators in place to get the ground running on this. In addition, established LCPF workers from other neighboring branches and LPOs (NALC's Legislative and Political Organizers) need to fully train, teach and mentor these committed individuals who want to learn the Legislative and Political aspects of our union. The process would take time, but our national numbers I guarantee if put in place with this idea would trend in the higher direction.

Finally, our CCA/PTF night is around the corner on **Tuesday April 4th**, **7:30pm to 9:30pm**. Any CCAs or PTFs who plan on attending (newly hired/promoted or current) please contact me asap if you plan on attending so I can get a head count.
