Presidents Report

I want to take this moment to thank everyone for their hard work and going the extra mile last month, on food drive day. We were put in a very bad situation when our cards never showed up from the national, who dropped the ball on getting us our cards. I don't want to blame anyone for this mishap, but we were registered, as we have been for the last 25 years, but they stated we weren't! Thanks to our Business agent, Brian Thompson, he was able to get us cards from other branches, which showed up on Wednesday and Thursday of the week of the food drive. We were able to get the cards to our offices and some offices also got bags, which definitely helped getting our numbers respectable. I have been told the south jersey food bank got their best turnout of all time, which makes me feel a little better, since I thought our branch would be a total disaster in doing our usual great showing. Once again, thank you to all who did their part to help feed those in need. Next, as I stated last month, our contract has expired as of May 20th, and as of this writing, they are still negotiating those items that can't be agreed to. Just so you know, nothing has changed, and everything stays the same until such a time as a new agreement is reached. Don't let anyone tell you the contract is no longer valid, as some have already tried saying! Keep checking the NALC website for all the latest updates, since this will be our last newsletter until September. Next, we have been talking about management placing carriers on the "Deems Desired" list for attendance. We now have 5 Step B decisions out of our Marlton office that states management must follow the provisions of the ELM 513.361 when requiring medical documentation in the future and must not be arbitrary, capricious or unreasonable. It appears management there thinks they can place anyone at any time on the Deems Desired list. These DRT decisions say they can't. If anyone runs into this same situation, please let your steward know so we can file the appropriate grievances. Another item that has been extended to our craft is the 520 annual leave carryover, which is now extended through the 2024 leave year. This is good news for those considering retiring in the next 2 years. Another concern our national is looking at concerns the overstaffing of some of our offices. I have asked your stewards to let me know if your office is overstaffed with CCA's and are not getting hours or are being consistently loaned out to other offices. Hopefully, this situation will be resolved with the next contract. Another thing I would like everyone to be aware of concerns Rural Carriers doing our craft work. I have been alerted this may be happening again in some offices. For the record, Rural carriers cannot work in our craft PERIOD! For the life of me, I can't understand why some of our carriers would allow this to occur right under their nose. Please stop this if you see it. If you don't want to get involved, please let me know the particulars and I will address it for you. I know some carriers say as long as they don't have to carry it, they don't care who does! Bad position to take. They didn't want to be part of our craft years ago when we asked them to consider it, so please don't let them do our work now. Just so you know, any work they do in our craft will get you paid cash money for all the hours they work. Think about that the next time you see them out there. Another item I want to remind everyone about is the heat that will soon be approaching. Please make sure you take all the proper safety precautions when dealing with the heat and stay hydrated. Also, please download the **OSHA/NIOSH heat safety App** from your play store. This should be with you at all times to help you navigate the heat this summer. Lastly, it was nice again to see the many new faces at last month's meeting and I hope this trend continues. Remember, this month is our **shrimp and wing feast** to start our summer break from meetings. Hope to see you there. Stay safe.

EVP's FYI

I would like to thank all the members of the greatest Branch in the NALC, Branch 908 for the opportunity to become your Executive Vice President. The topics I will be discussing with you all will be mostly about our rights and responsibilities as Letter Carriers, things we deal with daily. This month I will touch on how we handle the morning process on the workroom floor. This is probably one of the most discussed topics when I speak to Carriers regardless of years of service. This article will cover some basic advice on how to handle situations that carriers deal with. For more detailed advice please refer to the current NALC Letter Carrier Resource Guide found on NALC.org or on their APP. First you are required to orally inform your manager in accordance with sections 131.41, & 131.42 of Handbook M-41 if you believe can't carry the route in eight hours or within your normal schedule time. Request PS Form 3996 to fill out in accordance with Section 122.33 of Handbook M-39 which requires your manager to provide once you request it. If asked why the request, simply explain why calmly. immediately request to speak to your shop steward. Fill the form out, write in the request box why you can't complete your assignment in 8 hours. Please be specific and not general, your shop steward has and can provide you with a list of acceptable reasons to write down as a guide. Please don't be talked into not doing this procedure because they say the route shows a certain

time, by doing this you are allowing their tools to determine our times and our pace. This violates multiple national settlements examples such as M-01664, & M-01769 dealing with projections and our pace. Please remember nothing replaces the opinion of a professional letter carrier. Just simply provide your best estimate and reasons why. Please remember don't lose your temper, they want you to become frustrated. This will do nothing to help you, it will only hurt you. There is no reason to argue with them, simply just ask for your copy of the PS Form 3996 before you leave for the street in compliance with section 122.22 of Handbook M-39. Remember never compromise your safety or skip breaks and lunches to get back on time. We get paid to deliver mail; managers get paid to make decisions scary as that sounds. The carrier should proceed to contact the office in the afternoon per local instructions and inform them again that you can't make it back in their estimated times. Again, don't argue just simply ask should you continue, are they sending help, should I return with the mail I have left by a certain time, nothing more. Remember their bad day is not yours, don't take on undo stress. Stay Strong, Strength in Numbers. **Executive**

Ozzie's Corner

The White House released the 2024 Budget Proposal and there was great news to report. The report didn't call for cuts in programs under federal employees (including postal employees). The programs mentioned not to be affected were health benefits and retirement. The Budget Proposal calls for 12 weeks of paid family and medical leave. The Proposal also calls for Congress to include in the package at least 7 days of Sick Leave with the 12 weeks of leave. A childcare tax credit would be implemented, just like the measures that were under The American Rescue Plan Act in 2021, but with different dollar amounts. The 2024 childcare tax credit for a child under 6 years of age would be \$3,600 per child. A child 6 years of age and older would be \$3,000 per child. In 2021 under ARP (American Rescue Plan), the childcare tax credit was \$2,000 across the board for any age group.
